

1. THE FOLLOWING TERMS & CONDITIONS APPLY TO THIS PURCHASE ORDER AS IF FULLY SET FORTH HEREIN:
 - a. FOR PURCHASE ORDERS ("PO") ISSUED WITHOUT A GOVERNING CONTRACT, THE FOLLOWING GENERAL PURCHASE ORDER PROVISIONS (GPOPs), APPLY TO EACH PURCHASE ORDER.
 - i. AERO: HONEYWELL'S "GENERAL PURCHASE ORDER PROVISIONS (GPOPs) AERO" APPLY TO ANY PO ISSUED BY HONEYWELL-AEROSPACE
 - ii. HAT HIS: HONEYWELL'S "GENERAL PURCHASE ORDER PROVISIONS, (GPOPs) AERO HAT-HIS" APPLY TO ANY PO ISSUED BY HONEYWELL HAT-HIS ENTITIES.
 - iii. CAPEX: HONEYWELL'S "GENERAL PURCHASE ORDER PROVISIONS FOR CAPITAL EXPENDITURES (GPOPs) CEP" APPLY TO ANY PO ISSUED BY HONEYWELL FOR CAPITAL EXPENDITURES.
 - b. FOR PURCHASE ORDERS ISSUED AGAINST U.S. GOVERNMENT – FUNDED CONTRACTS, THE FOLLOWING SUPPLEMENTAL PURCHASE ORDER PROVISIONS APPLY IN ADDITION TO THE APPLICABLE GPOP ABOVE:
 - i. HONEYWELL'S "SUPPLEMENTAL PROVISIONS UNDER FIXED PRICE U.S. GOVERNMENT CONTRACTS" (SP/FFP) APPLY TO ANY CONTRACT OR PURCHASE ORDER IF THE CONTRACT OR PURCHASE ORDER IS SUBJECT TO ANY PROVISION OR REGULATION APPLICABLE TO A UNITED STATES GOVERNMENT CONTRACT.
 - ii. HONEYWELL'S "GENERAL COST REIMBURSABLE PROVISIONS" (SP/GCRP) APPLY TO ANY COST REIMBURSABLE CONTRACT OR PURCHASE ORDER.
2. US EQUAL EMPLOYMENT OPPORTUNITY REGULATIONS. TO THE EXTENT EMPLOYMENT ACTIVITIES OF SUPPLIER OCCUR IN THE UNITED STATES AND IF OTHERWISE APPLICABLE **THIS CONTRACTOR AND SUBCONTRACTOR SHALL ABIDE BY THE REQUIREMENTS OF 41 CFR §§ 60-1.4(a), 60-300.5(a) AND 60-741.5(a)**. THESE REGULATIONS PROHIBIT DISCRIMINATION AGAINST QUALIFIED INDIVIDUALS BASED ON THEIR STATUS AS PROTECTED VETERANS OR INDIVIDUALS WITH DISABILITIES, AND PROHIBIT DISCRIMINATION AGAINST ALL INDIVIDUALS BASED ON THEIR RACE, COLOR, RELIGION, SEX, SEXUAL ORIENTATION, GENDER IDENTITY OR NATIONAL ORIGIN. CONFLICT MINERAL COMPLIANCE: IN ACCORDANCE WITH APPLICABLE "CONFLICT MINERALS" LAWS, HONEYWELL MUST DETERMINE WHETHER ITS PRODUCTS CONTAIN TIN, TANTALUM, TUNGSTEN OR GOLD ("3TG") ORIGINATING IN THE DEMOCRATIC REPUBLIC OF THE CONGO AND ADJOINING COUNTRIES ("CONFLICT MINERALS"). TO THE EXTENT SUPPLIER SUPPLIES DIRECT MATERIALS CONTAINING 3TG TO HONEYWELL UNDER THIS PURCHASE ORDER, SUPPLIER COMMITS TO HAVE A SUPPLY CHAIN PROCESS TO ENSURE AND DOCUMENT A REASONABLE INQUIRY INTO THE COUNTRY OF ORIGIN OF THE 3TG MINERALS INCORPORATED INTO PRODUCTS IT SUPPLIES TO HONEYWELL. IF REQUESTED, SUPPLIER WILL PROMPTLY PROVIDE INFORMATION OR REPRESENTATIONS THAT HONEYWELL REASONABLY BELIEVES ARE REQUIRED TO MEET ITS CONFLICT MINERALS COMPLIANCE OBLIGATIONS.
4. TO ENSURE COMPLIANCE WITH U.S. EXPORT LAWS, HONEYWELL DOES NOT CONDUCT ANY BUSINESS TRANSACTIONS WITH PERSONS OR COMPANIES ON THE "DENIED

PERSONS LIST" PUBLISHED BY THE U.S. DEPARTMENT OF COMMERCE, THE "DEBARRED PARTIES LIST" PUBLISHED BY THE DEPARTMENT OF STATE, AND THE "SPECIALLY DESIGNATED NATIONALS" PUBLISHED BY THE DEPARTMENT OF TREASURY, FOREIGN ASSETS CONTROL. HONEYWELL EXPECTS ALL SUPPLIERS AND ITS SUBCONTRACTORS TO COMPLY WITH THESE LAWS AS WELL.

5. THE FOLLOWING INFORMATION IS PROVIDED TO ASSIST WITH INTERPRETING PRIME CONTRACT AND DPAS FLOW DOWN ON HONEYWELL AEROSPACE PURCHASE ORDERS:
 - a. IF THE FLOW DOWN REFLECTS A PRIME CONTRACT NUMBER AND A DPAS RATING, THE CORRESPONDING QUANTITY IS PEGGED TO FIRM DEMAND FLOWING DOWN A U.S. GOVERNMENT PRIME CONTRACT NUMBER AND DPAS RATING.
 - b. IF THE FLOW DOWN REFLECTS A PRIME CONTRACT NUMBER AND A DPAS OF "NONE", THE CORRESPONDING QUANTITY IS PEGGED TO FIRM DEMAND FLOWING DOWN A U.S. GOVERNMENT PRIME CONTRACT NUMBER THAT IS "NOT RATED".
 - c. IF THE FLOW DOWN REFLECTS "INDEPENDENT REQUIREMENT" IN THE PRIME CONTRACT NUMBER FIELD AND "NONE" IN THE DPAS FIELD, THE CORRESPONDING QUANTITY IS PEGGED TO CSSO OR FORECAST DEMAND INTENDED FOR U.S. GOVERNMENT END USE.
 - d. IF THE FLOW DOWN REFLECTS "NONE" IN THE PRIME CONTRACT NUMBER FIELD, BUT DOES FLOW DOWN A DPAS RATING, THE CORRESPONDING QUANTITY IS PEGGED TO NON-U.S. 'MILITARY' END USE THAT CARRIES A DPAS RATING.
 - e. IF THE FLOW DOWN REFLECTS "NONE" IN THE PRIME CONTRACT NUMBER FIELD AND "NONE" IN THE DPAS FIELD, THE CORRESPONDING QUANTITY IS PEGGED TO COMMERCIAL OR NON-U.S. GOVERNMENT END USE THAT DOES NOT CARRY A DPAS RATING.
 - f. IF THE PO CONTAINS "TBD" IN EITHER FIELD (PRIME CONTRACT NUMBER AND/OR DPAS), PLEASE CONTACT BUYER TO GET THE PO CORRECTED.

NOTE: "INDEPENDENT REQUIREMENT" IS AN ACCEPTABLE DESIGNATION.
